

4.1 Chittering Bushfire Advisory Committee meeting: 13 October 2020

4.1 OFFICER RECOMMENDATION Moved Peter Watterston/Seconded Peter Hall That the minutes of the Chittering Bushfire Advisory Committee meeting held on Tuesday, 13 October 2020 be confirmed as a true and accurate record of proceedings. CARRIED UNANIMOUSLY

5. ANNOUNCEMENTS WITHOUT DISCUSSION

5.1 Community Emergency Services Manager / Chief Bushfire Control Officer

David Carroll spoke to the following:

- Began with introductions to various members of the Brigades and their roles.
- Currently in the Prohibited Burning Period, going restricted 31 March unless conditions allow sooner
- Weather Forecast March – May
 - For the fortnight of 8 to 21 March, maximum temperatures are likely to be warmer than average across the west coast of WA. Much of southern WA is likely to be cooler than average.
 - Minimum temperatures for the fortnight 8 to 21 March are likely to be warmer than average across most of WA away.
 - Mean maximum temperatures for autumn (March to May) are likely to be higher than average (greater than 60% chance) for the south-west coast of WA. Cooler than average maximum temperatures are likely (greater than 60% chance) for parts of southern inland WA.
 - Autumn minimum temperatures are likely to be higher than average across most of Australia except for parts of southern WA. Chances of warmer nights are greater than 80% along the west coast of WA.
 - We have had strong easterly's for weeks on end with little or no sea breeze.
 - We still have the pre wet weather frontal activity to get through, where we have hot dry conditions and strong winds prior to the passing of cold fronts and rain.
 - Autumn is likely to be wetter than average across most of Western Australia.
- Several incidents since Christmas Eve including major incidents at Red Gully, Oakford and Wooroloo on 1 Feb, 86 houses lost, hot dry day with strong easterly's all day and overnight, creating high intensity fast moving bushfire generating 55,000kw/m or more (prescribed burn is around 350kw/m, general firefight 1000kw/m). Thanks to all brigade members and their families for their ongoing support and commitment to the community.

- Thanks to the team, Deputy Chiefs, Captains and FCOs for permit writing, community education and engagement. The Shire team, Councillors, Matt, Peter Stuart, Graham, the Rangers Matty and Barry, Jodie and the office staff and DFES DO Murray McBride for ongoing support of our volunteer brigades

5.2 DFES District Officer – North East Metropolitan

Murray McBride spoke to the following:

- Murray introduced himself and gave his personal and professional background to the Committee.
- Thanks was given to brigades and their members for their attendance at recent large scale incidents including Wooroloo and Red Gully.
- There is a review into the Wooroloo Fire initiated by DFES.
- The Office of Bushfire Risk Management are looking at the Wooroloo incident including the fuel loads and road reserves in the affected area.
- Wooroloo incident has been officially closed by DFES today.
- Volunteers can register for the COVID-19 vaccination through the volunteer portal.

Peter Watterston asked if a volunteer has an adverse reaction to the vaccine which results in that person not being able to work, would that volunteer be covered. Murray stated that he did not have a response to this question.

- Bushfire Centre of Excellence in Shire of Murray is now open.
- Emergency Services Radio Network – WA Government is investing more than sixty million dollars with a project staged over eight years.

5.3 Chief Executive Officer

Matthew Gilfellon spoke to the following:

- Thanks given to all brigades and their families for their contributions at the Red Gully and Wooroloo fires
- The Shire has held a debrief after the recent warnings that effected the Shire of Chittering during the Wooroloo incident.
- The Shire has organised a Red Cross Preparedness Workshop in Lower Chittering. The intention of the workshop is to educate residents how to prepare for emergency situations in future.
- Community Forums are organised in the coming months which will also include further information on Emergency Management.

6. PREVENTION (MITIGATION, COMPLIANCE AND ENFORCEMENT)

6.1 Fire Danger Rating Sign, Great Northern Highway near Wandena Road

Matthew Gilfellon spoke to the following:

Following the Committee's recommendation at the October meeting, Council resolved the following at their Ordinary Meeting of Council on 18 November 2020:

SUBSTANTIVE MOTION / COUNCIL RESOLUTION 221120

Moved Cr Ross / Seconded Cr Curtis

That Council by an ABSOLUTE MAJORITY:

- 1. Authorises the Shire to consult Main Roads Western Australia on placement of the sign prior to purchase of the sign.*
- 2. Authorises the purchase of a Fire Danger Rating sign in accordance with the purchasing policy after a favourable agreement is made with Main Roads Western Australia.*
- 3. Authorises the placement of the purchased electronic Fire Danger Rating sign on Great Northern Highway (near Wandena Road) to notify the public of Fire Danger Ratings in preparation for the 2020/21 Fire Season.*
- 4. That if there is an undue delay for the Fire Danger Rating Sign to be installed by 31 January 2021 for the 2020/21 fire season that this purchase be considered as part of the 2021/22 budget.*

CARRIED 6/0

Following this resolution, the Shire contacted Main Roads WA (Wheatbelt division) to initiate discussions about the Fire Danger Rating sign and its placement. The reception from Main Roads WA was positive however more information such as drawings and an exact location was requested to inform a decision. Subsequently, two quotes and drawings have been requested from suppliers. To date, one quote has been received from a supplier and the second is pending.

As the Shire has been unable to install the sign by 31 January 2021, the costings for the purchase and installation of the Fire Danger Rating sign will now form part of the Shire of Chittering Budget 2021/22.

Murray McBride addressed the Committee and stated that the design of the Fire Danger Rating signs may change in the near future. Murray stated that he would find out more information and provide it to the Committee.

6.2 Shire Mitigation Activities under Mitigation Activity Funding

David Wilson addressed the meeting to request a report on current Mitigation Activities under Mitigation Activity funding. David Wilson requested whether this item could be a regular item at Committee meetings to keep all Fire Control Officers and other members informed of mitigation activities.

Graham Furlong stated that the Shire was successful with obtaining funding for forty one treatments. A summary is available and can be circulated to the Committee for their reference. Treatments include the verges on Bindoon-Dewars Pool Road and Chittering Road (from Great Northern Highway through to Lower Chittering Station). Graham to provide the report to Jodie for circulation with the minutes.

6.3 Strategic Firebreak Mapping

David Wilson addressed the meeting to discuss the Strategic Firebreak document and request for the document to be updated and distributed. David Carroll stated that the latest document is from 2011. It was acknowledged that the information is outdated and efforts will be made to update the document and circulated.

6.4 Emergency Access Tracks, Escape Tracks & Gate Locks

Peter Watterston addressed the meeting to request information regarding the upkeep and checking of tracks in the Shire and the use of combination locks on the gates. Peter used Morley Road as an example. A strategic break was used during the Rural Urban Interface exercise and there were difficulties with locks on this particular firebreak. Peter stated that there are similar issues with Windermere Way. Peter went on to suggest whether locks could be changed to combination locks instead of the Shire firebreak padlocks.

Peter Watterston went on to request whether brigades should be checking firebreaks and giving feedback to the Shire on their upkeep. Peter added that the strategic firebreak between Hart Drive and

Shane Robertson and Johan Rossouw shared experiences with strategic firebreaks in the Shire where there were issues with locks.

Peter Hall introduced himself to those present. Peter requested whether there was going to be a road linking Santa Gertrudis Drive and Blue Plains. Matthew Gilfellon stated that there is a road between Maryville Heights stage one and Chittering Springs stage one. It is normally up to the developer to develop the road as part of their subdivision.

6.5 Burning on Sundays in the Restricted Burning Time

Peter Watterston addressed the meeting requesting whether along permits on a Sunday can be considered. David Carroll stated that this item had been addressed in previous meetings. Matthew Gilfellon stated that the item could be heard. David Carroll stated that there had been no changes and that the answer remained the same as previous meetings.

7. RESPONSE

7.1 Shire of Chittering's Response during Emergencies

David Wilson addressed the meeting and requested what are the response plans that are in place in the event of Emergency Warnings being issued during an incident in the Shire of Chittering.

Matthew Gilfellon presented information on Emergency Management and the Shire's obligations (see attachment 1).

David Wilson detailed that he had checked the Shire of Chittering Facebook page during the incident and did not see much information posted on the second day of the Wooroloo incident, especially in comparison to other Local Governments. Matthew Gilfellon stated that communication was a gap identified in the internal debrief after the incident. Information was scarcely reported in most aspects during the incident.

Shelly stated that the most reliable source of information for the public is the DFES Emergency website. David Wilson stated that the feedback from Lower Chittering members was that there wasn't enough information being posted through the Shire. Shelly stated that people panic during large incidents and potentially can get the wrong information from other sources on Facebook. Peter Watterson concurred, stating that some people listen to radios and spread information that is potentially incorrect. David Carroll stated that there has been issues similar to this in the past. The Committee discussed warnings, the DFES Emergency website and its importance.

8. RECRUITMENT & TRAINING

8.1 Training Coordinator Report

Scott Ormsby was not in attendance to speak to his items as provided at the time of agenda. Scott's resignation as the Shire of Chittering Training Coordinator was tabled.

David Carroll and David Wilson stated that they were in process of finding a new candidate for the Training Coordinator role.

9. RESOURCES & FACILITIES

9.1 Enhancement of Shire of Chittering Brigades

Matthew Gilfellon gave background on what steps the Shire took in response to the request to enhance the Shire's Volunteer Bush Fire Brigades (VBFB) to Volunteer Fire and Emergency Services (VFES). Information regarding the potential enhancement has been verbal to date but no formal notice has been received from DFES. Matthew stated that this discussion was for Committee members and other senior brigade members in attendance to provide feedback and make comments on behalf of their respective brigades. Feedback and comments were intended to inform the Councillors present.

Peter Watterston spoke on behalf of Bindoon VBFB and began with background on the brigade's understanding on the transition to date. Peter added that the brigade had initially voted to become enhanced and have decided as a majority to go against this decision. Peter stated that Bindoon do not wish to continue with the transition due to constraints regarding training and potential membership issues.

Murray McBride provided information in response to information provided by Peter. Murray additionally provided information on becoming VFES and other brigades' transitions. David Wilson provided his concerns including the impost on management, additional reporting, more requirements to meet and training. David stated that there is the likelihood that brigades will struggle most of these obligations. Other concerns included equipment. David stated that allegedly core equipment is provided and that extra equipment that would need to be purchased by the brigades. Murray provided further feedback on these concerns and detailed the types of models that are available for enhanced brigades.

There was further discussion held by the Committee about other changes that the brigade would experience if they become enhanced. David Wilson also detailed the potential issue with not having a Community Emergency Services Manager. Murray provided more feedback regarding these issues. Murray stated that information was quite broad due to the lack of a formal response from DFES. Peter Hall thanked Murray for his attendance and stated that he would like to wait for formal

notification from DFES. Additionally, Peter stated that a green paper is proposed to come out mid-year. Peter requested for the green paper to be considered as well as formal notification from DFES before decisions be made. Murray agreed that formal notification should be received from DFES before a formal decision is made.

MOTION

Moved Peter Hall/Seconded Peter Watterston

That the Chief Executive Officer liaise with the brigades to prepare a letter to the DFES Commissioner to seek clarification.

CARRIED UNANIMOUSLY

Kim asked the Committee whether the discussion about changing to VFES was necessary. David Carroll detailed the changes that the Shire is going through and the impact this may have on Emergency Services in future. Cr Carmel Ross stated that the discussion on this issue will help to guide Council's decision. Murray stated that Commissioner's office has requested his input on bringing Bush Fire Brigades from Local Government to DFES and this implies that there is intention to transition brigades over.

Matthew Gilfellon stated that the main feedback required from brigades was why they wished to move to VFES. Peter Watterston detailed the reasons why brigade decided initially to be enhanced.

Councillor Carmel Ross requested feedback from Shelly Pannell on behalf of Muchea VBFB. Shelly provided background on Muchea's perspective on enhancement. Shelly stated that Muchea have always been a Bush Fire Brigade and believes that there is not a need for enhancement right now.

Graham Furlong instigated Shelly detailing the discussion that was had with Merv Austic from DFES. Merv Austic's portrayal of the transition was considered to be a positive perspective in contrast to the perspective given by Chris Unstead.

Johan Rossouw, speaking on behalf of Lower Chittering VBFB, stated that his brigade did not wish to move to enhanced brigade however acknowledged the benefits it could have.

Peter Hall clarified the motion and his intentions for the motion.

Johan Rossouw stated that there has been no facts that have been presented to the brigade to date.

Aaron Cover stated, on behalf of Upper Chittering VBFB, that the brigade has no interest in being an enhanced brigade. Aaron deferred to Will Lee for comment from the gallery. Will Lee concurred with Shelly that there isn't enough information or a true depiction of what the transition entailed. Additionally Will stated that Upper Chittering VBFB have no interest in the change.

Richard stated that Wannamal VBFB are happy with the way their brigade currently operates.

Peter Watterston added that having a Community Emergency Services Manager has great value to brigades in having that contact and losing that would make going to VFES less appealing. Murray McBride responded saying that it's not known what structure would be implemented if brigades were enhanced. Further discussion was held by the Committee about how potentially it would work.

Councillor Carmel Ross summarised that it was evident that no one was in a position to make an informed decision due to the lack of information provided to date. The Committee resolved for a

letter to be sent to the Commissioner which will provide time to consider the decision and provide further information to the Committee and the Brigades.

11.1 Setting of meeting date for June

In accordance with Council Resolution 211120, the Chittering Bushfire Advisory Committee are required to determine whether a meeting is required to be held in June. The decision will require a unanimous vote from the Committee.

Triggers for an ISG

The triggers for an incident support group are defined in State EM Policy Statement 5.2.2 and State EM Plan Section 5.1. These are:

- (a) Where an incident is designated as Level 2 or higher;
- (b) Multiple agencies need to be coordinated.

Potential Hazards That We Face

State Emergency Management Plans

The State Emergency Management Committee (SEMC) has responsibility to arrange the preparation of state level plans that cover specific hazard support issues.

Local Government Welfare Liaison Officer	During an evacuation where a local government facility is utilised by the Department of Communities provide advice, information and resources regarding the operation of the facility.
Local Government Liaison Officer (to the ISG/IMT)	During a major emergency, the liaison officer attends ISG meetings to represent the local government and provide local knowledge input and details in the LEMA.

Welfare In An Emergency

As per Section 5.5.4 of the State Emergency Management Plan, the Department of Communities is responsible for the EM activity of providing welfare services (r. 32 EM Regulations). - personal services;
- registration and reunification; and
- financial assistance.
