### QUESTION 1 - What locality do you live in?

#### **SUMMARY**


The majority of the trail users reside within Lower Chittering (150), Bullsbrook/Swan Valley (41) or in Chittering (24). There were several trail users which reside a significant distance from the trails, with users residing in Northam/Toodyay (3), Wannamal (2), Rockingham (1) and York (1).

A total of 265 people responded to this question with 54 respondents skipping this question.




### QUESTION 2-Do you current own or ride horses?

#### **SUMMARY**

The majority of survey respondents claim to own or ride horses (219) compared to the respondents who do not own or ride horses (38).

A total of 257 people responded to this question with one respondent skipping this question.




### QUESTION 3 - Have you used the Maryville Downs Bridle trail in the last 12 months?

#### **SUMMARY**

205 of the survey respondents have reportedly used the Maryville Downs bridle trail within the last 12 months. 52 respondents have not used the trails.

A total of 257 people responded to this question with one respondent skipping this question.




## QUESTION 4 - If yes, how frequently have you used the Maryville Downs Bridle Trail in the last 12 months?

#### **SUMMARY**

The majority of users claim to have used the trail 1-3 times within the last 12 months (82), with 69 respondents using it monthly, 41 using it weekly and 12 using it multiple times a week. 39 users claim not to have used the trail at all.

A total of 245 people responded to this question and 13 respondents skipped this question.

### QUESTION 5 - How would you rate your overall experience using the Maryville Downs Bridle Trail?

#### **SUMMARY**

The majority of survey respondents were either 'very satisfied' or 'satisfied' with the trails (192). 16 respondents were either 'dissatisfied' or 'very dissatisfied' with the trails, and 19 respondents were neutral on the matter.

A total of 242 people responded with 31 respondents skipping this question.


15 comments were made on this question, with positive and negative feedback of the trails provided.




## QUESTION 6 - Have you used the Powderbark Estate Bridle Trail in the last 12 months?

#### **SUMMARY**

144 survey respondents have stated that they have ridden the Powderbark Estate bridle trails within the last 12 months, with 107 stating that they have not used this trail.

A total of 251 people responded with seven respondents skipping this question.




# QUESTION 7-1f yes, how frequently have you used the Powderbark Estate Bridle Trail in the last 12 months

#### **SUMMARY**

The majority of respondents have either not used the Powderbark Estate trail (76) or have only used it 1-3 times within the last 12 months (80). 36 claim to use this trail monthly, 19 weekly and 11 multiple times a week.

A total of 222 people responded with 36 respondents skipping this question.

### QUESTION 8 - How would you rate your overall experience using the Powderbark Estate Bridle Trail?

#### **SUMMARY**

The majority of users were either 'very satisfied' (64) or 'satisfied' (78) with the overall experience of the Powderbark Estate trails. Three users were 'dissatisfied' and seven users were 'very dissatisfied'. 34 users were neutral on the matter.

A total of 201 people responded with 72 respondents skipping this question.


Fifteen comments were provided with this question, with a summary of these comments being that they've either never rode the trail or that it is too short.

### QUESTION 9 - How would you prefer to access the bridle trails?

#### **SUMMARY**

Question 9 relates to the users preferred way to access the bridle trails. This question allowed the user to select multiple responses and as such, there was a total of 283 responses to this question from 217 users, with 41 respondents skipping this question. 38% would prefer to ride their horse from their own property and 8% would prefer to walk their horse to the beginning of the trails. 48% claim that they would prefer to drive and float their horse to the beginning of either trail. 5% selected 'other' and provided a comment in relation to this question, with the summary being that the majority are happy to access the trails in any capacity.


A total of 283 responses were made to this question from 217 individuals, with 41 respondents skipping this question.


## QUESTION 10 - How far would you be willing to walk your horse on the road to access the trail?

#### **SUMMARY**

The majority of survey respondents claim that they do not want to walk their horse for more than 1km on a road to access the trail (95). 59 state that they would walk between 1-3km on the road(s) with 12 users willing to walk 3-5 and 5lm+ respectively. 48 respondents would not walk on the roads at all.

A total of 226 people responded with 32 respondents skipping this question.

# QUESTION 11 - Have you encountered any of the following issues while using the trail?

#### **SUMMARY**

This question allowed respondents to select as many answers that were applicable.

89 respondents claimed that they have no issues with the bridle trails. The main concern that the survey respondents have with the trails is motorbikes or unauthorised vehicles accessing the trails at the same time as the users. Other concerns were trail hardness (43), adjoining landowner conflicts (36), parking problems (24), lack of signage (20) and issues with gates (10).


A summary of the 19 comments relating to this question is that users are concerned with the trail ground being hard, better signage, issues with unauthorised vehicles and dogs on adjoining properties.

- "Too hard of ground"
- "Horses in adjoining properties spooking horses trunk to access the final entry near Guernsey Rise."

- "One particular local doing drivebys in their car getting very close. Poss needs to be reminded of the road rules"

- "Maps on your website seems to lack any topography when I tried to access through phone""I haven't. Encountered motorbikes but have seen social media posts where people have and that has deterred me from using the trail recently."
- "Nothing on the bridle trail, just drivers awareness of slowing down for horses on the road to the bridle trail. Not something shire has control over but could be good to raise awareness of passing slow and wide please!"
- "Signage could be better"
- "Cars slowed on road crossovers. Neighbouring land owner came and patted the horses!"
- "Stoney and can be sore for horses feet if unprepared and don't bring boots"

### QUESTION 12 - Are there any improvements you would suggest for the current trail?

#### **SUMMARY**

86 responses were provided to this question. A summary of the answers is that general positive comments for the trails and constructive comments encouraged better signage/parking, softer ground, better gates to limit access of unauthorised vehicles and the possibility of a looped trail track. Opposing comments encouraged the trails to be closed to privacy and security/theft concerns of adjoining properties along the trails. 172 respondents skipped this question.

- "Softer ground area for a canter/gallop"
- "Possibly space for float parking"
- "Better parking please. The Maryville downs trail parking gets quite boggy when wet and makes it tough to get floats in and out."
- "Keep it open"
- "Better advertising, wasnt aware of the trails until this survey was posted!"
- "please keep this option available to minimise horses on the roads. i support giving them somewhere to excercise freely."
- "Would like to open it up to walking dogs as well."
- "Some softer areas would be great. Currently there aren't many places to canter."
- "Gate or obstacle to restrict / inconvenience trail bike entry. Mounting Block places after any Entry obstacle or gate installed. And at Trailhead or at nice point along trail where taking a break would be indicated."
- "Perhaps plant/offer some privacy trees along the side of the trail where the disgruntled residents live. In my opinion if people move out here they should be aware that its a semi-rural/rural area with wildlife and horse riders, but for those that didn't get the memo some privacy screening to keep them in their own backyard like surburbia may be more to their liking."

We hope to use it in the future and that the network of trails gets expanded."



# QUESTION 13 - Do you have a preference for the style of gates at the access point of the trails?

#### **SUMMARY**

75 respondents stated that they do not have a preference as to which kind of gate could potentially be implemented along the trails. 66 respondents are satisfied with the current setup and to leave the gates open permanently. 58 would prefer a form of 'stepover gate' and 39 would prefer a gate with a latch that is accessible from horseback. 20 respondents skipped this question.

### QUESTION 14 - Would you support the trails remaining open on a permanent basis?

#### **SUMMARY**


The majority of the survey respondents wish for the trails to remain open on a permanent basis, with 219 respondents in support of the trails. 17 stated that they would support the trails remaining open if there were further changes made. 20 respondents stated that they would not support the trails remaining open, with 1 respondent remaining 'neutral' and 1 skipping the question. 26 comments relating to this question expressed the respondents views on the trails, with the comments ranging from wishing for softer ground, and better signage/accessibility, to requests that the trails be closed permanently due to the impacts on adjoining property owners.

# QUESTION 15 - Do you have a story or experience using the Bridle Trails that you would like to share that isn't captured by the questions of this survey?

- "The use of fire breaks as a bridal trail is absolutely insane. What will happen when there is an emergency & fire trucks etc need access however horses are in the way?? The fact that land owners bought their land with the understanding the fire break is there property not public property?? Horse riders have also now assumed that all fire breaks are bridal trails and are riding their horses along other firebreaks & abusing land owners for simply protecting their own land. Horse poo is being left on our land attracting flies and bad smells and horse riders have no regard"

Our property having over a 400m in common with the trail it has been a very anxious time. We have lived in our home for over 23yrs and built it with no notice of intention from the Shire that the strategic firebreak would ever be open as a public throughfare.  There is a constant flow of people on the firebreak and we admit some are quiet horse riders doing the right thing but as they rise past our house, they feel they have the right to call out to us or our children or our dogs. We hear them comment on the property in our shed and our land. They film themselves riding and post it on social media oblivious that they are filming our private property and belongings and posting it. It was very unsettling that they feel they have to right to intrude into our home.  We have built a house yard fence to contain our dog within a house yard and not allowing it to be able to go up the to the boundary fence to of the firebreak. This has only been an issue since the bridal trail has been open as many (most) people bring their dogs with them. Allot of people use the firebreak for the specific purpose, of walking their dog. There is a gentleman that parks his 80 series Landcruiser (rego # 8MJ432) at the cult er-sac of Jersey and walks his dog up and down the fire rbeak every day.  Dogs can walk along our 400m property boundary and even enter our property as the fence line has been damaged by kanagaroos and enter our property. Meanwhile our animals are contained within a small house yard. This doesn't seem right on our 40acre property?  Will the Shire be doing maintenance on this fence line?  The firebreak is frequent by a white hilux ute and trailer, I think they go out collecting firewood. It scares us when you see lights going along the firebreak when you know vehicles shouldn't be on it. Its also used by off road motorbikes quiet often and late at night is worrying to













"This has been an amazing asset, it's brought in people from other areas and helped with the community as I've now met many more people in the area. Everyone has been respectful."



		As you can appreciate, ratepayers such as myself—who are directly impacted—deserve more than silence and delay. The fire break was constructed for one purpose only: fire safety. It was never intended to be converted into a recreational trail. Allowing this is not only inappropriate but also unfair to residents who have lived here for decades, when the breaks were locked and secured.
		The people most affected are those of us who built here over 20 years ago, not the newer arrivals with larger blocks who now feel entitled to walk around private homes with no form of license, registration, or accountability. This is unacceptable and needs to be addressed.
		To add to the frustration, I have personally been denied permission to install another septic system on my property to accommodate a granny flat for one of my children. Yet, the council seems willing to open and even extend a trail without consultation, notice, or due consideration for residents. The inconsistency is disgraceful.
		I am demanding urgent action on this matter, or at the very least, a formal response with clear reasoning as to why this decision has been made. Ratepayers deserve transparency and respect on issues that impact our homes and safety.

	Chittering	adjoining firebreak has always been locked and used solely as an emergency access track for firefighters. It was never intended or designed as a public recreational trail.
		The recent decision to open this track to the public has created significant risks, infringements, and burdens for myself, my family, and other residents along the boundary.
		2. Key Concerns 2.1 Loss of Privacy and Amenity
		My home is only 10 metres from the boundary.

- Opening the track has destroyed our privacy in both the backyard and front yard, including our pool area.
- This has directly reduced the value and enjoyment of my property.

#### 2.2 Uncontrolled Public Access

- The track is being used not only by locals but also by people floating horses in from outside the area.
- There is no system of registration, control, or accountability in place.
- This has transformed a firebreak into an unregulated public facility at the expense of adjacent residents.

#### 2.3 Security, Safety, and Harassment

- My wife feels unsafe in her own home, and we are forced to secure our dogs and property at all times.
- My work vehicle has been filmed and uploaded to social media without my consent, requiring action to have it removed.
- On multiple occasions, riders have deliberately pointed cameras in my face while passing, which is intimidating and hostile.

#### 2.4 Lack of Rider Accountability

- Riders are using the track without helmets, training, or licensing.
- The risks fall solely on residents, while the benefit is limited to a small group of recreational users.

#### 2.5 Compromised Emergency Response

- Police, fire, and ambulance services in the area are already under strain and cannot reliably arrive in good time.
- This track was established as an emergency fire access route.
- Recreational use risks obstructing emergency services during a crisis, which could have catastrophic consequences.

#### 2.6 Failure to Consult Fire Services

- Despite being Shire land, no formal consultation was undertaken with the local fire station.
- As the authority most directly responsible for using this track in an emergency, their exclusion is unacceptable.

#### 2.7 Unfair Burden During Cost-of-Living Crisis

- Residents are already facing financial stress from rising rates and the cost-of-living crisis.
- The Shire's decision has further reduced property values, compromised security, and increased household stress.

### 2.8 Liability and Accountability I hereby place the Shire on formal notice: Any damage to my fences, stock, or property, or Any obstruction of emergency access arising from this decision, will be considered the direct responsibility of the Shire. 3. Demand for Action This track is dangerous, unnecessary, and has been opened without proper regard for the safety, privacy, or security of affected residents. I formally request that the Shire: 1. Immediately review and reverse the decision to open the firebreak for recreational use. 2. Restore the track to its original purpose as an emergency access route. 3. Consult directly with affected residents and local fire services before making any further decisions. 4. Position Going Forward Let me be absolutely clear: I will be opposing this decision to the very end, and I will not be backing down at any stage. Troy 434 Santa Dear Sir/Madam, Partridge Gertrudis Drive, Lower I am writing as a long-term ratepayer of over 20 years at 434 Santa Chittering Gertrudis Drive to express my deep concern and disappointment with the recent opening of the horse trail adjacent to my property. This decision was made without any consultation or notification to affected residents. As both a horse owner and a community member, I find it highly disrespectful that we were not given the courtesy of being informed, let alone asked for input, before such a significant change to the use of this land. Since the trail opened, my family has experienced a number of serious issues: I have had to spend over \$2,000 on security systems because my children's and grandchildren's rooms are only 15 metres from the walkway. We have had motorcycles, cars, and members of the public treating the trail as a general walk track, not just for There have been two incidents of broken windows and repeated disturbances at night, causing my wife great stress when I am away. The privacy of my home and pool area has been completely lost.

I am now forced to confine my dogs whenever people use the trail, despite the risk not being of my making.
When carrying out genuine use of my tractor and

 When carrying out genuine use of my tractor and motorbike on my property, I have been abused and told to switch them off by people passing on the trail.

This is not what I bought my property for, and it has fundamentally changed how my family must live.

I also note that new estates are being developed in the area. If a trail was required, it should have been incorporated into those estates where new residents would purchase their land fully aware of its existence. Instead, long-standing residents like myself have had our amenity stripped away without consultation.

I further understand that some council staff have actively supported and promoted this process on social media platforms without consideration for those directly affected. This is highly inappropriate and only adds to the sense that community voices have been disregarded.

The land in question was originally designated as an emergency track, and I developed my property on that basis. If people wish to ride, there are appropriate facilities elsewhere — the burden should not fall on a handful of existing families who now carry the impacts.

I am trying to remain respectful in raising this matter, but I must stress that my family's wellbeing, security, and privacy have already been severely compromised. Extending consultation by another three months does not ease concerns when the decision appears to have already been made.

I request that the Council urgently review this matter, halt the use of the trail, and engage in genuine consultation with affected residents before proceeding further.

	Crittering	We would strongly urge the Shire to close the bridal trial. Our property having over a 400m in common with the trail it has been a very anxious time. We have lived in our home for over 23yrs and built it with no notice of intention from the Shire that the strategic firebreak would ever be open as a public throughfare.
		There is a constant flow of people on the firebreak and we admit some are quiet horse riders doing the right thing but as they rise past our house, they feel they have the right to call out to us or our children or our dogs. We hear them comment on the property in our shed and our land. They film themselves riding and post it on social media oblivious that they are filming our private property and belongings and posting it. It was very unsettling that they feel they have to right to intrude into our home.
		We have built a house yard fence to contain our dog within a house yard and not allowing it to be able to go up the to the boundary fence to of the firebreak. This has only been an issue since the bridal trail has been open as many (most) people bring their dogs with them. Allot of people use the firebreak for the specific purpose, of walking their dog. There is a gentleman that parks his 80 series Landcruiser (rego # 8MJ432) at the cult er-sac of Jersey and walks his dog up and down the fire rbeak every day.
		Dogs can walk along our 400m property boundary and even enter our property as the fence line has been damaged by kanagaroos and enter our property. Meanwhile our animals are contained within a small house yard. This doesn't seem right on our 40acre property?
		Will the Shire be doing maintenance on this fence line?
		The firebreak is frequent by a white hilux ute and trailer, I think they go out collecting firewood. It scares us when you see lights going along the firebreak when you know vehicles shouldn't be on it. Its also used by off road motorbikes quiet often and late at night is worrying to hear them. There is another white 4wheel drive that drives very fast up and down the firebreak.
		The fire breaks were built with the intention of use by emergency vehicles and fire escape routes, not for the public to have access to and have negative impacts on bordering properties. Please respect the landowners adjoining this firebreak that pay rates and maintain fence lines and have built own homes along this firebreak. Not all that are using the bridal trial are local and I think the Shire should be looking out for local residents' rights and concerns.


