

3. ADOPTION OF MINUTES FROM PREVIOUS MEETING

The minutes of the meeting held on 23 March 2023 were adopted without any amendments.

4. INTRODUCTION & WELCOME NEW TEAM MEMBERS

Carmel Ross provided an introduction of the new Shire team members. Natasha Muir addressed the group providing a short introduction. Melinda Prinsloo addressed the group to provide an introduction to Andrea Venn. It's been noted that both staff members are welcome to future CTAG meetings as observers.

5. CHITTERING TOURIST STATISTICS QUARTERLY UPDATE

Statistics were shared as per the attached presentation (Attachment 1).

The members commented on previous concerns raised at the last meeting over the online booking tool. As there is a significant increase in transit park bookings, it appears the system is working and guests are utilising the tool. Members are happy to continue as is.

Chris Waldie addressed the group to provide statistics on the museum. For the period of Feb 2023 to May 2023, there was 280 visitors to the museum. More buses are stopping in, and often go to the Arts and Craft building and pottery shed. Many also enjoy morning tea at the museum.

6. MEMBERSHIP OF CTAG

Chris Waldie contacted Kay McDonald, who explained he is unable to commit to the timeslot of meetings due to a personal health matter.

Gina Sanderson has resigned verbally. No formal resignation in writing has been received.

Chris Waldie's position within committee was discussed as Chris is not an official committee member. Committee voted and unanimously agreed to recommend to council that Chris be formally appointed a member in the June meeting.

<u>Action:</u> The CEO will prepare an agenda item for the June Ordinary Council Meeting with a recommendation from CTAG that Chris Waldie be appointed as a voting member of the group.

7. MOUNTAIN BIKE PARK PROJECT UPDATE

Melinda Prinsloo provided a Mountain Bike Park project update. Resignation of Shire officers has resulted in project delays. Looking at end October at the earliest for soft launch to hikers and MTB group.

<u>Action:</u> Natasha Muir to organise a community update to be provided through Northern Valley News as well as Shire Facebook page and eChatter.

8. MOUNTAIN BIKE PARK REFERENCE GROUP UPDATE

Melinda Prinsloo provided an update on the Mountain Bike Park Reference Group. Council representative is Cr Mark Campbell and CTA representative is Natalie Vallance. CCC decided they would not have a member in the group and would instead prefer to put forward a representative after the project completion as they are interested in ongoing business support and economic development.

9. TASTE OF CHITTERING STEERING GROUP & EVENT UPDATE

Natasha Muir addressed the committee to provide an update on the taste of Chittering progress. The first steering committee meeting was held 24th May where the date and venue were – Sunday 27th August at Binda Place.

Expression of Interest Survey was sent out to locals, farmers market stallholders and previous stall holders. As of this meeting there were 57 responses.

At the steering committee it was decided to increase the cost for stallholders as last year's was kept low to encourage support for the event following a disappointing 2021 event. The stall fees will be included in the FY2023-24 Shire budget. New stall prices were listed in the expression of interest survey. Other logistics for the event are underway and currently seeking quotes including toilets, parking, traffic management and waste. Avon Waste is donating their services again this year.

Also reached out to Chalice and Tronox for sponsorship, both have responded positively so details are being negotiated.

The committee provided comments on coffee providers and suggested Natasha to contact Cup of Eden and East African Coffee to gauge interest in the event.

Discussion was also had in regards to a licenced area. Natasha is currently investigating a licensing area and will have updates to the steering committee in due course.

10. SPRING FESTIVAL

Chris Waldie addressed the group on behalf of Colleen Osborn in regards to Springfest.

Contactor Natalie Swannell will be on board to help organise and promote the event starting in a week.

Natalie Vallance addressed the group to explain what Muchea Tree Farm has planned in relation to the festival. There will be an open day an Art Exhibition on the 2nd September.

The Wildflower Exhibition will be in the Wannamal Hall this year.

It was discussed that Natalie reach out to the Bindoon Art Society and Bindoon Men's Shed for assistance with easels if needed.

It was noted that SpringFest will commence at Taste of Chittering and events will be spread across September.

11. HISTORIC VEHICLES DAY

Chris Waldie addressed the group in regards to the Bindoon and Districts Historic Vehicle Day. It will be combined with the Bindoon Farmers Market to allow for liquor producers to have stalls on the day.

1,500 flyers will be distributed. Expecting 200-250 cars and 30 stallholders/food vans.

Curtin Radio is holding a similar event on the same day but hopefully it will not impact on this event.

12. BUDGET CONSULTATION

Melinda Prinsloo addressed upcoming budget items as per presentation (Attachment 2).

Also discussed the possibility of holding business workshops run through larger neighbouring shires.

13. OTHER DISCUSSION

The Terms of Reference were discussed and it was requested that they be sent to committee members with the next agenda for members to read and discuss at the next scheduled meeting.

<u>Action:</u> Natasha will include the Terms of Reference with the agenda paper for the September meeting.

Bindoon Agricultural Show is scheduled for 14 October 2023 organised by Melissa Elton. Expressions of interest currently taking place.

Citrus Classic Fondo cancelled by WestCycles so it will not be going ahead. As the event involved grant funding the Shire is working to hold onto the grant for another similar event, however, the terms and conditions of the grant may make it impossible.

14. NEXT MEETING

The next meeting will be scheduled for 6pm on 14 September 2023 in the Shire Council Chambers. This timing will allow for feedback on Taste of Chittering to be prepared for presentation at the meeting.

The Chairperson declared the meeting closed at 7:05pm







Bureau of Meteorology Long-range forecast overview

Issued: 8 June 2023

Rainfall Summary: drier than average July to September for much of Australia

For July, below median rainfall is likely to very likely (60% to greater than 80% chance) for most of Australia, excluding some regions of east coast Australia, northern and western Australia, and southern Tasmania.

For July to September, below median rainfall is likely to very likely (60% to greater than 80% chance) for much of Australia, excluding coastal NSW, parts of northern Australia and a band stretching from the Ningaloo Coast of Western Australia to central South Australia.

For July to September, large parts of far southern mainland Australia are at least twice as likely to receive unusually low rainfall (where unusually low rainfall equates to the driest 20% of July to September periods over 1981–2018).

Past accuracy of July to September long-range forecasts for the chance of above median rainfall has generally been moderate to high for most of Australia, increasing to high to very high for parts of eastern Australia.

Temperature Summary:

Warmer than average days and nights for most of Australia during July to September

For July, above median maximum temperatures are likely to very likely (60% to greater than 80% chance) for most of Australia, excluding some small areas in the northern tropics.



For July to September, above median maximum temperatures are very likely (greater than 80% chance) for most of Australia, decreasing to likely (60 to 80% chance) for most of the northern tropics.

Most of the southern two-thirds of Australia is at least three times more likely than average to experience unusually high maximum temperatures during July to September (where unusually high maximum temperatures equate to the warmest 20% of records at this time of the year), with areas of south-east and western Australia being more than four times as likely to experience unusually high maximum temperatures.

For July, above average minimum temperatures are likely to very likely (60% to greater than 80%) for most of Tasmania, some southern and eastern coastal regions, parts of the northern tropics and parts of western and northern Western Australia. Below average minimum temperatures are likely (60-80%) for a region of eastern South Australia.

For July to September, minimum temperatures are likely to very likely (60% to greater than 80% chance) to be above median for most of Australia.

Past accuracy of the July to September chance of above median maximum temperature long-range forecasts has been moderate to high across most of Australia, excluding a region in the south-east of the Northern Territory extending into western Queensland where accuracy drops to low. For minimum temperatures, accuracy has been moderate to very high, excluding most of the western half of Western Australia and south-east Australia, where accuracy drops to low.

5.2 DFES District Officer – North East Metropolitan

Murray McBride spoke to the following:

- DFES State Operations will be requesting expressions of interest through the Community Emergency Service Managers for firefighters who are able to attend international deployment to assist in the current wildfires in Canada.
- There have been some mitigation burns conducted recently in Mundaring thanks was given to those who assisted.
- WAFES Conference in September people who wish to attend should register in advance as there is the potential extra costs may be incurred in relation to accommodation. There have been issues in previous years with regard to numbers and availability.
- Two operational courses are being organised Murray is currently waiting for numbers for attendance in order to book in dates.
- Current industrial action has caused DFES training to be postponed.
- A response plan for the Bindoon Army Camp was created before previous high threat period.
 The response plan is currently being reviewed and worked on for the next high threat period.
- A working group has been assembled regarding the DFES Total Fire Ban procedures. Feedback regarding the Fire Danger Rating system can be passed to Murray to relay.
- Chief Bushfire Control Officer Forum is being held from Wednesday 19 July to Friday 21 July. This is available for Deputy Chiefs to attend also.



5.3 Chief Executive Officer

Melinda Prinsloo spoke to the following:

- Deep appreciation and thanks to:
 - Every volunteer, for making the community a safer place. For members and for their families supporting them when volunteering;
 - The Deputy Chiefs Kim, Phil and Dave for their hard work and support throughout the year; and
 - Paul and Dennis for their ongoing support of Bindoon Volunteer Bush Fire Brigade as Executive Managers.
- Melinda stated that she hoped to see all members and their partners at the Recognition Event being held Saturday 17 June.

6. PREVENTION (MITIGATION, COMPLIANCE & ENFORCEMENT)

6.1 New Norcia Incident & the Bindoon Bypass

Kim Haeusler addressed the meeting and stated that over the past few months that there had been multiple incidents involving trucks carrying Ammonium Nitrate. He stated that there was a considerable risk to Bindoon with the amount of traffic that passed through the town site carrying the same type of cargo. Kim enquired whether Shire had heard from Main Roads regarding when they expected to continue construction of the Bindoon Bypass.

Cr Carmel Ross stated that there had been limited correspondence with updates. She continued that when inspected, the information pertaining to this project on the Main Roads website had not been updated for a year. Cr Ross suggested that it was possible that Council and the Shire could use these recent incidents as a basis to lobby the state government to get the Bindoon Bypass to be completed.

The details of the New Norcia incident were discussed and the impact of the evacuation of the town. Dave Carroll provided an update regarding his recent correspondence with Main Roads. Further discussion was held by the Committee regarding the status of the Bindoon Bypass project.

Paul Groves enquired whether an exercise had been conducted on evacuating the town in the event of a similar incident.

Murray McBride stated that exercises of a similar nature had been held and the purpose of LEMC for exercising. The Committee held further discussion on impact of an incident occurring in Bindoon. Murray provided information about DFES HAZMAT and what work they are doing since the recent incident.

Gordon Carter enquired about response to sodium cyanide and what the response would be in such an incident. The Committee discussed incident response and responsibility of Hazard Management Agencies, in particular transport related incidents.



Cr Carmel Ross enquired whether an exercise could be run at a future LEMC meeting and whether Main Roads WA attend to provide input and outline their involvement. The Committee had further discussion on response and moved the following motion:

That the Committee recommends to Council that the Chief Executive Officer:

- 1. Resumes lobbying Main Roads WA to proceed with the construction of the Bindoon Bypass with particular focus on the danger posed to the town of Bindoon by the large number of plackarded trucks with hazardous materials passing through the townsite.
- 2. Make contact with Main Roads WA requesting details of their response plans for emergencies that arise in or near Bindoon until the Bypass has been constructed.

7.1 Leadership Training

David Wilson addressed the meeting to present information about a Leadership Development Program for members of the Chittering Fire Service. A recent meeting was held with Captains and challenges faced by brigades with regards to membership and future management of the brigades. To date, there had been overwhelming support for the program.

David detailed what the program entailed and what was planned to implement the program in future. He stated that some other exercises were planned to help develop members in a more proactive way. David requested feedback from the brigades on what would work to ensure the program's success. Other Community Emergency Service Managers have also shown interest in the program and it does not conflict with existing DFES courses.

- (2) The Chief Bush Fire Control Officer is to table the minutes of the bush fire brigade's annual general meeting at the next meet of the—
 - (a) Bush Fire Advisory Committee; or
 - (b) Council, if there is no Bush Fire Advisory Committee.

3.9 Functions of Advisory Committee

The Bush Fire Advisory Committee is to have the functions set out in section 67 of the Act and is to include such number of nominees of the bush fire brigades as determined by the local government.

3.10 Advisory Committee to nominate bush fire control officers

As soon as practicable after the annual general meeting of each bush fire brigade in the district, the Bush Fire Advisory Committee is to nominate to the local government from the persons nominated by each bush fire brigade a person for the position of a bush fire control officer for the brigade area.

3.11 Local government to have regard to nominees

When considering persons for the position of a bush fire control officer, the local government is to have regard to those persons nominated by the Bush Fire Advisory Committee, but is not bound to appoint the persons nominated.

3.12 Advisory Committee to consider bush fire brigade motions

The Bush Fire Advisory Committee is to make recommendations to the local government on all motions received by the Bush Fire Advisory Committee from bush fire brigades.

That the Shire conducts further research into the Aboriginal Cultural Heritage Act and is to provide an update to members at the next Committee meeting.





For July to September, large parts of far southern mainland Australia are at least twice as likely to receive unusually low rainfall (where unusually low rainfall equates to the driest 20% of July to September periods over 1981–2018).

Past accuracy of July to September long-range forecasts for the chance of above median rainfall has generally been moderate to high for most of Australia, increasing to high to very high for parts of eastern Australia.

Temperature Summary:

Warmer than average days and nights for most of Australia during July to September

For July, above median maximum temperatures are likely to very likely (60% to greater than 80% chance) for most of Australia, excluding some small areas in the northern tropics.



For July to September, above median maximum temperatures are very likely (greater than 80% chance) for most of Australia, decreasing to likely (60 to 80% chance) for most of the northern tropics.

Most of the southern two-thirds of Australia is at least three times more likely than average to experience unusually high maximum temperatures during July to September (where unusually high maximum temperatures equate to the warmest 20% of records at this time of the year), with areas of south-east and western Australia being more than four times as likely to experience unusually high maximum temperatures.

For July, above average minimum temperatures are likely to very likely (60% to greater than 80%) for most of Tasmania, some southern and eastern coastal regions, parts of the northern tropics and parts of western and northern Western Australia. Below average minimum temperatures are likely (60-80%) for a region of eastern South Australia.

For July to September, minimum temperatures are likely to very likely (60% to greater than 80% chance) to be above median for most of Australia.

Past accuracy of the July to September chance of above median maximum temperature long-range forecasts has been moderate to high across most of Australia, excluding a region in the south-east of the Northern Territory extending into western Queensland where accuracy drops to low. For minimum temperatures, accuracy has been moderate to very high, excluding most of the western half of Western Australia and south-east Australia, where accuracy drops to low.

5.2 DFES District Officer – North East Metropolitan

Murray McBride spoke to the following:

- DFES State Operations will be requesting expressions of interest through the Community Emergency Service Managers for firefighters who are able to attend international deployment to assist in the current wildfires in Canada.
- There have been some mitigation burns conducted recently in Mundaring thanks was given to those who assisted.
- WAFES Conference in September people who wish to attend should register in advance as there is the potential extra costs may be incurred in relation to accommodation. There have been issues in previous years with regard to numbers and availability.
- Two operational courses are being organised Murray is currently waiting for numbers for attendance in order to book in dates.
- Current industrial action has caused DFES training to be postponed.
- A response plan for the Bindoon Army Camp was created before previous high threat period.
 The response plan is currently being reviewed and worked on for the next high threat period.
- A working group has been assembled regarding the DFES Total Fire Ban procedures. Feedback regarding the Fire Danger Rating system can be passed to Murray to relay.
- Chief Bushfire Control Officer Forum is being held from Wednesday 19 July to Friday 21 July. This is available for Deputy Chiefs to attend also.



5.3 Chief Executive Officer

Melinda Prinsloo spoke to the following:

- Deep appreciation and thanks to:
 - Every volunteer, for making the community a safer place. For members and for their families supporting them when volunteering;
 - The Deputy Chiefs Kim, Phil and Dave for their hard work and support throughout the year; and
 - Paul and Dennis for their ongoing support of Bindoon Volunteer Bush Fire Brigade as Executive Managers.
- Melinda stated that she hoped to see all members and their partners at the Recognition Event being held Saturday 17 June.

6. PREVENTION (MITIGATION, COMPLIANCE & ENFORCEMENT)

6.1 New Norcia Incident & the Bindoon Bypass

Kim Haeusler addressed the meeting and stated that over the past few months that there had been multiple incidents involving trucks carrying Ammonium Nitrate. He stated that there was a considerable risk to Bindoon with the amount of traffic that passed through the town site carrying the same type of cargo. Kim enquired whether Shire had heard from Main Roads regarding when they expected to continue construction of the Bindoon Bypass.

Cr Carmel Ross stated that there had been limited correspondence with updates. She continued that when inspected, the information pertaining to this project on the Main Roads website had not been updated for a year. Cr Ross suggested that it was possible that Council and the Shire could use these recent incidents as a basis to lobby the state government to get the Bindoon Bypass to be completed.

The details of the New Norcia incident were discussed and the impact of the evacuation of the town. Dave Carroll provided an update regarding his recent correspondence with Main Roads. Further discussion was held by the Committee regarding the status of the Bindoon Bypass project.

Paul Groves enquired whether an exercise had been conducted on evacuating the town in the event of a similar incident.

Murray McBride stated that exercises of a similar nature had been held and the purpose of LEMC for exercising. The Committee held further discussion on impact of an incident occurring in Bindoon. Murray provided information about DFES HAZMAT and what work they are doing since the recent incident.

Gordon Carter enquired about response to sodium cyanide and what the response would be in such an incident. The Committee discussed incident response and responsibility of Hazard Management Agencies, in particular transport related incidents.



Cr Carmel Ross enquired whether an exercise could be run at a future LEMC meeting and whether Main Roads WA attend to provide input and outline their involvement. The Committee had further discussion on response and moved the following motion:

That the Committee recommends to Council that the Chief Executive Officer:

- 1. Resumes lobbying Main Roads WA to proceed with the construction of the Bindoon Bypass with particular focus on the danger posed to the town of Bindoon by the large number of plackarded trucks with hazardous materials passing through the townsite.
- 2. Make contact with Main Roads WA requesting details of their response plans for emergencies that arise in or near Bindoon until the Bypass has been constructed.

David Wilson addressed the meeting to present information about a Leadership Development Program for members of the Chittering Fire Service. A recent meeting was held with Captains and challenges faced by brigades with regards to membership and future management of the brigades. To date, there had been overwhelming support for the program.

David detailed what the program entailed and what was planned to implement the program in future. He stated that some other exercises were planned to help develop members in a more proactive way. David requested feedback from the brigades on what would work to ensure the program's success. Other Community Emergency Service Managers have also shown interest in the program and it does not conflict with existing DFES courses.

- (2) The Chief Bush Fire Control Officer is to table the minutes of the bush fire brigade's annual general meeting at the next meet of the—
 - (a) Bush Fire Advisory Committee; or
 - (b) Council, if there is no Bush Fire Advisory Committee.

3.9 Functions of Advisory Committee

The Bush Fire Advisory Committee is to have the functions set out in section 67 of the Act and is to include such number of nominees of the bush fire brigades as determined by the local government.

3.10 Advisory Committee to nominate bush fire control officers

As soon as practicable after the annual general meeting of each bush fire brigade in the district, the Bush Fire Advisory Committee is to nominate to the local government from the persons nominated by each bush fire brigade a person for the position of a bush fire control officer for the brigade area.

3.11 Local government to have regard to nominees

When considering persons for the position of a bush fire control officer, the local government is to have regard to those persons nominated by the Bush Fire Advisory Committee, but is not bound to appoint the persons nominated.

3.12 Advisory Committee to consider bush fire brigade motions

The Bush Fire Advisory Committee is to make recommendations to the local government on all motions received by the Bush Fire Advisory Committee from bush fire brigades.

That the Shire conducts further research into the Aboriginal Cultural Heritage Act and is to provide an update to members at the next Committee meeting.





Bureau of Meteorology Long-range forecast overview

Issued: 8 June 2023

Rainfall Summary: drier than average July to September for much of Australia

For July, below median rainfall is likely to very likely (60% to greater than 80% chance) for most of Australia, excluding some regions of east coast Australia, northern and western Australia, and southern Tasmania.

For July to September, below median rainfall is likely to very likely (60% to greater than 80% chance) for much of Australia, excluding coastal NSW, parts of northern Australia and a band stretching from the Ningaloo Coast of Western Australia to central South Australia.

For July to September, large parts of far southern mainland Australia are at least twice as likely to receive unusually low rainfall (where unusually low rainfall equates to the driest 20% of July to September periods over 1981–2018).

Past accuracy of July to September long-range forecasts for the chance of above median rainfall has generally been moderate to high for most of Australia, increasing to high to very high for parts of eastern Australia.

Temperature Summary:

Warmer than average days and nights for most of Australia during July to September

For July, above median maximum temperatures are likely to very likely (60% to greater than 80% chance) for most of Australia, excluding some small areas in the northern tropics.



For July to September, above median maximum temperatures are very likely (greater than 80% chance) for most of Australia, decreasing to likely (60 to 80% chance) for most of the northern tropics.

Most of the southern two-thirds of Australia is at least three times more likely than average to experience unusually high maximum temperatures during July to September (where unusually high maximum temperatures equate to the warmest 20% of records at this time of the year), with areas of south-east and western Australia being more than four times as likely to experience unusually high maximum temperatures.

For July, above average minimum temperatures are likely to very likely (60% to greater than 80%) for most of Tasmania, some southern and eastern coastal regions, parts of the northern tropics and parts of western and northern Western Australia. Below average minimum temperatures are likely (60-80%) for a region of eastern South Australia.

For July to September, minimum temperatures are likely to very likely (60% to greater than 80% chance) to be above median for most of Australia.

Past accuracy of the July to September chance of above median maximum temperature long-range forecasts has been moderate to high across most of Australia, excluding a region in the south-east of the Northern Territory extending into western Queensland where accuracy drops to low. For minimum temperatures, accuracy has been moderate to very high, excluding most of the western half of Western Australia and south-east Australia, where accuracy drops to low.

5.2 DFES District Officer – North East Metropolitan

Murray McBride spoke to the following:

- DFES State Operations will be requesting expressions of interest through the Community Emergency Service Managers for firefighters who are able to attend international deployment to assist in the current wildfires in Canada.
- There have been some mitigation burns conducted recently in Mundaring thanks was given to those who assisted.
- WAFES Conference in September people who wish to attend should register in advance as there is the potential extra costs may be incurred in relation to accommodation. There have been issues in previous years with regard to numbers and availability.
- Two operational courses are being organised Murray is currently waiting for numbers for attendance in order to book in dates.
- Current industrial action has caused DFES training to be postponed.
- A response plan for the Bindoon Army Camp was created before previous high threat period.
 The response plan is currently being reviewed and worked on for the next high threat period.
- A working group has been assembled regarding the DFES Total Fire Ban procedures. Feedback regarding the Fire Danger Rating system can be passed to Murray to relay.
- Chief Bushfire Control Officer Forum is being held from Wednesday 19 July to Friday 21 July. This is available for Deputy Chiefs to attend also.



5.3 Chief Executive Officer

Melinda Prinsloo spoke to the following:

- Deep appreciation and thanks to:
 - Every volunteer, for making the community a safer place. For members and for their families supporting them when volunteering;
 - The Deputy Chiefs Kim, Phil and Dave for their hard work and support throughout the year; and
 - Paul and Dennis for their ongoing support of Bindoon Volunteer Bush Fire Brigade as Executive Managers.
- Melinda stated that she hoped to see all members and their partners at the Recognition Event being held Saturday 17 June.

6. PREVENTION (MITIGATION, COMPLIANCE & ENFORCEMENT)

6.1 New Norcia Incident & the Bindoon Bypass

Kim Haeusler addressed the meeting and stated that over the past few months that there had been multiple incidents involving trucks carrying Ammonium Nitrate. He stated that there was a considerable risk to Bindoon with the amount of traffic that passed through the town site carrying the same type of cargo. Kim enquired whether Shire had heard from Main Roads regarding when they expected to continue construction of the Bindoon Bypass.

Cr Carmel Ross stated that there had been limited correspondence with updates. She continued that when inspected, the information pertaining to this project on the Main Roads website had not been updated for a year. Cr Ross suggested that it was possible that Council and the Shire could use these recent incidents as a basis to lobby the state government to get the Bindoon Bypass to be completed.

The details of the New Norcia incident were discussed and the impact of the evacuation of the town. Dave Carroll provided an update regarding his recent correspondence with Main Roads. Further discussion was held by the Committee regarding the status of the Bindoon Bypass project.

Paul Groves enquired whether an exercise had been conducted on evacuating the town in the event of a similar incident.

Murray McBride stated that exercises of a similar nature had been held and the purpose of LEMC for exercising. The Committee held further discussion on impact of an incident occurring in Bindoon. Murray provided information about DFES HAZMAT and what work they are doing since the recent incident.

Gordon Carter enquired about response to sodium cyanide and what the response would be in such an incident. The Committee discussed incident response and responsibility of Hazard Management Agencies, in particular transport related incidents.



Cr Carmel Ross enquired whether an exercise could be run at a future LEMC meeting and whether Main Roads WA attend to provide input and outline their involvement. The Committee had further discussion on response and moved the following motion:

That the Committee recommends to Council that the Chief Executive Officer:

- 1. Resumes lobbying Main Roads WA to proceed with the construction of the Bindoon Bypass with particular focus on the danger posed to the town of Bindoon by the large number of plackarded trucks with hazardous materials passing through the townsite.
- 2. Make contact with Main Roads WA requesting details of their response plans for emergencies that arise in or near Bindoon until the Bypass has been constructed.

7.1 Leadership Training

David Wilson addressed the meeting to present information about a Leadership Development Program for members of the Chittering Fire Service. A recent meeting was held with Captains and challenges faced by brigades with regards to membership and future management of the brigades. To date, there had been overwhelming support for the program.

David detailed what the program entailed and what was planned to implement the program in future. He stated that some other exercises were planned to help develop members in a more proactive way. David requested feedback from the brigades on what would work to ensure the program's success. Other Community Emergency Service Managers have also shown interest in the program and it does not conflict with existing DFES courses.

3.7 Nomination of bush fire control officers to Bush Fire Advisory Committee

At the annual general meeting of a bush fire brigade, brigade member/s are to be nominated to the Bush Fire Advisory Committee to serve as the bush fire control officer for the brigade until the next brigade annual general meeting.

3.8 Minutes to be tabled before the Bush Fire Advisory Committee

- (1) The brigade Secretary is to forward a copy of the minutes of the annual general meeting of a bush fire brigade to the Chief Bush Fire Control Officer within one month after the meeting.
- (2) The Chief Bush Fire Control Officer is to table the minutes of the bush fire brigade's annual general meeting at the next meet of the—
 - (a) Bush Fire Advisory Committee; or
 - (b) Council, if there is no Bush Fire Advisory Committee.

3.9 Functions of Advisory Committee

The Bush Fire Advisory Committee is to have the functions set out in section 67 of the Act and is to include such number of nominees of the bush fire brigades as determined by the local government.

3.10 Advisory Committee to nominate bush fire control officers

As soon as practicable after the annual general meeting of each bush fire brigade in the district, the Bush Fire Advisory Committee is to nominate to the local government from the persons nominated by each bush fire brigade a person for the position of a bush fire control officer for the brigade area.

3.11 Local government to have regard to nominees

When considering persons for the position of a bush fire control officer, the local government is to have regard to those persons nominated by the Bush Fire Advisory Committee, but is not bound to appoint the persons nominated.

3.12 Advisory Committee to consider bush fire brigade motions

The Bush Fire Advisory Committee is to make recommendations to the local government on all motions received by the Bush Fire Advisory Committee from bush fire brigades.

43. Election and duties of officers of bush fire brigades

A local government which establishes a bush fire brigade shall by its local laws provide for the appointment or election of a captain, a first lieutenant, a second lieutenant, and such additional lieutenants as may be necessary as officers of the bush fire brigade, and prescribe their respective duties.
