

4.1 Chittering Bushfire Advisory Committee meeting: 11 March 2025

4.1 OFFICER RECOMMENDATION

5. REPORTS

5.1 Community Emergency Services Manager / Chief Bushfire Control Officer

Nathan Manning addressed the Committee and spoke to the following:

- Thanks were given to all brigades for the last fire season. There was 340ha lost over the past season.
- A discussion was held at a recent Captains meeting about minimising call outs over the unrestricted burning time and encouraging residents to register their burns on Emergency WA.
- A Bushfire Safety Awareness course was recently held in June. A Bushfire Fighting Skills course
 is due to be held on 19 July 2025. More courses are currently being considered, once booked
 in, Nathan will inform brigades.
- WAERN course that was booked for early June was cancelled due to trainer availability and will potentially be booked again in conjunction with another Local Government.
- Structural Firefighting training to potentially be held in conjunction with Bullsbrook in August.



- Work on the Brigade Operating Procedures continues. Nathan is developing a roadmap to be sent to brigades.
- A Volunteer Culture & Satisfaction Survey is being developed and will be sent to members. The outcome of the survey will help drive what needs to be improved for brigades.
- The submitted Local Government Grant Scheme application is still to be confirmed.
- Update provided on vehicles including the new Upper Chittering Light Tanker. Additional updates were given on future Muchea and Wannamal appliances.
- Urgent replacement of HeartSine Samaritan AED Pads has been conducted in accordance with DFES Safety Circular 04/2025.

Carmel invited questions from the Committee and Observers. Carmel enquired about the Structural Firefighting training. Nathan provided information on the brigade's duties in response to a structural fire. Daniel Smith asked for more information about the Structural Firefighting course and Nathan provided more detail and confirmed that it would be a practical drill.

5.2 DFES District Officer – North East Metropolitan

Murray McBride addressed the meeting and spoke to the following:

- There has been a third deployment to Canada. Murray received an email with short timeframes. If anyone is interested to go on deployment, please register on the Deployment Register.
- A Sector Commander Course is planned to be delivered for the first time since its revision in North East Metropolitan region. Details of the course will be circulated when determined.
- A joint Incident Control Vehicle exercise is planned for September in Forrestfield at the Academy. The objective of the exercise is to refine the process with multiple Incident Control Vehicles at large incidents.

Phill Humphry enquired if there was an age limit for the Canada deployment which Murray confirmed that there was. Daniel Smith asked about the Sector Commander course being available to bushfire brigades. Murray confirmed that it would be and further information will be made available.

5.3 Chief Executive Officer

Melinda Prinsloo addressed the meeting and spoke to the following:

- Following the Flat Rocks Road fire in February, one of the key challenges identified was the difficulty in contacting property owners regarding the incident and its impacts.
 - In response, on 19 May 2025, the Shire conducted a bulk mailout to landowners with incomplete contact details on our records, requesting updates to ensure effective communication during future emergencies.
 - Recruitment flyers for the brigades were included in the mailout.
 - We have had a good response to both the letter and flyers. The Shire has had about ten recruitment responses through the website, and each have been sent to the Captains as they have been received.

A bush fire brigade is to hold its annual general meeting during the month of May each year.

3.7 Nomination of bush fire control officers to Bush Fire Advisory Committee

At the annual general meeting of a bush fire brigade, brigade member/s are to be nominated to the Bush Fire Advisory Committee to serve as the bush fire control officer for the brigade until the next brigade annual general meeting.

3.8 Minutes to be tabled before the Bush Fire Advisory Committee

- (1) The brigade Secretary is to forward a copy of the minutes of the annual general meeting of a bush fire brigade to the Chief Bush Fire Control Officer within one month after the meeting.
- (2) The Chief Bush Fire Control Officer is to table the minutes of the bush fire brigade's annual general meeting at the next meet of the—
 - (a) Bush Fire Advisory Committee; or
 - (b) Council, if there is no Bush Fire Advisory Committee. following their receipt under subclause (1)

3.9 Functions of Advisory Committee



The Bush Fire Advisory Committee is to have the functions set out in section 67 of the Act and is to include such number of nominees of the bush fire brigades as determined by the local government.

3.10 Advisory Committee to nominate bush fire control officers

As soon as practicable after the annual general meeting of each bush fire brigade in the district, the Bush Fire Advisory Committee is to nominate to the local government from the persons nominated by each bush fire brigade a person for the position of a bush fire control officer for the brigade area.

3.11 Local government to have regard to nominees

When considering persons for the position of a bush fire control officer, the local government is to have regard to those persons nominated by the Bush Fire Advisory Committee, but is not bound to appoint the persons nominated.

3.12 Advisory Committee to consider bush fire brigade motions

The Bush Fire Advisory Committee is to make recommendations to the local government on all motions received by the Bush Fire Advisory Committee from bush fire brigades.

43. Election and duties of officers of bush fire brigades

A local government which establishes a bush fire brigade shall by its local laws provide for the appointment or election of a captain, a first lieutenant, a second lieutenant, and such additional lieutenants as may be necessary as officers of the bush fire brigade, and prescribe their respective duties.

8. GENERAL BUSINESS

Shelly Pannell addressed the meeting and requested to move a motion to appoint two more Deputy Chief Bush Fire Control Officers. Shelly detailed the dynamic that other Shires have with additional Deputies. The Committee discussed the role of the Deputy Chief, the value they have had in Chittering historically and the reason for only being two in place currently. Melinda Prinsloo outlined the current arrangement and made a recommendation for the consideration to appoint two more Deputies at Chittering to be deferred until the succession planning report has been delivered by Nathan.

Murray McBride detailed previous experiences while Graham acted as Chief Bush Fire Control Officer, and the difficulties faced with not having Deputies in place. Shelly stated that the Shire needs a succession plan in place to ensure the Shire will have future Deputies. Murray detailed the restructure at Swan and the reasons they reduced the number of Deputies they had. Graham Furlong highlighted the importance of the Captain-Fire Control Officer roles. Graham also stated that it had been considered whether there is a need for Deputies if there are no duties for them to perform. Melinda stated that the correct procedure must be followed and affirmed that it was Nathan Manning's role to implement an appropriate plan. Nathan confirmed that he had started looking into the roles and responsibilities of Deputies and outlined high level duties performed by existing Deputies. Nathan also provided an overview of what could be implemented. The Committee discussed different perspectives on having additional Deputies before agreeing on the following motion:

To recommend to Council that the appointment of up to two additional deputies be investigated, covering the following items:

- 1. Support provided by DFES personnel to develop the role and responsibility statement for the position.
- 2. The appropriate recruitment process to identify a suitable candidate or candidates.
- 3. The outcome of that investigation to be tabled and considered at the October Chittering Bushfire Advisory Committee meeting.
