The Shire will be looking at the business continuity plan as the centre mentioned for the Shire to use during an emergency is not set up with internet access.

- Shire has renewed the MOU with DFES with regard to the position of the Community Emergency Services Manager for a further three years.
- At the OCM held on 17 May 2017 the Shire's Bushfire Risk Planning Coordinator presented the Shire's Bushfire Risk Management Plan, which Council resolves as follows:
 - SUBSTANTIVE MOTION/COUNCIL RESOLUTION 030517 Moved Cr Osborn / Seconded Cr Rossouw

That Council:

- endorses the Bushfire Risk Management Plan for the Shire of Chittering as per Attachment 1. 1.
- resolves that the Bushfire Risk Management Plan has equal standing to that of the Local 2. Biodiversity Strategy.

Advice Note:

Council consider allocating a financial contingency in the draft 2017/2018 budget in the case that the Bushfire Risk Planning Coordinator role discontinues due to cease of funding. This will allow for the treatment options as identified in the Bushfire Management Plan to continue.

SUBSTANTIVE MOTION WAS PUT AND DECLARED CARRIED 6/0

The BRMP assessed the whole Shire by addressing risks and assessing private properties in the 'Extreme' areas. By reducing lot sizes and installing firebreaks around properties better chance of asset protection. The Shire has applied for funding (\$10,000) through AWARE to engage the community with emergency management/preparedness, the Shire to match 50:50.

Yvette advised that the Shire's funding request was well received and rated highly at the District Office.

- The Shire received notification from Wheatbelt District Emergency Management committee that a cross boundary district exercise will be held in Gingin on 13 June 2017. Alan Sheridan will be on annual leave; however invitations extended to the Shire's Executive Managers to attend.
- The Shire received notification from the Office of Emergency Management with regard to local governments being able to use their own labour, plant and equipment for the rebuilding of essential public assets as part of the January WANDARA event (Chittering Shire not involved).

5.7 District EM Advisor, Officer of Emergency Management

Capability and Preparedness Questionnaire – due 14th June 2017

Each year state agencies, service providers and LGs are asked to complete a preparedness questionnaire. The data from this is used to develop a preparedness report that goes to parliament to advise on the state's preparedness.

The survey was sent out to all local governments recently and is due by the 14th June 2017.

Measuring resilience or preparedness is a complex task. So the a state capability framework has been developed that sets some core objectives for the state to aim for. Benchmarks or best practice if you like. It aligns with national models, but has been tweaked to suit WA. There are 7 capability areas and 32 core capabilities. The questionnaire is based on these.


CAPABILITY FRAMEWORK

Steve Duggan from the Bureau of Meteorology gave a seasonal outlook at a recent flood preparedness workshop held in Northam.

Of interest were his comments that while it appears winters are becoming drier, there is a tendency for monsoon rains to come further south in summer, and summers may become wetter than average, certainly in the short term it seems to be the trend. In top of an already wet catchment, this could mean further flooding, next summer. Also severe thunderstorms, microbursts similar to what occurred in Kellerberrin a few weeks ago, are becoming more common.

Reporting period from 28 February 2017 to 31 May 2017 *Major events and incident coordination*

- Total Number of Incidents: 7
- List Significant Event and any critical issues identified:
 - Land Search 3 May 2017 Walyunga NP. Missing person located deceased. Team debrief conducted and wellness and peer support has been offered.
- Summary of incidents by type of call:
 - Storm / Severe Weather 4 with 8 premises attended
 - Land Search 3
- Current membership is 57 members including 3 probation members.

Seasonal risk preparation briefings

• Training focus for this next quarter is on Storm Damage Operations, Basic General Rescue and Radio Communications.

EM Exercises attended

• A Level 2 Storm exercise is planned in the SIMCEN 21 June 2017.

Any other issues involving EM

- Communications 400 MHz spectrum changes. DFES are required to make changes to UHF radio systems. This will require a transition of all UHF channels (frequencies). Swan SES are currently waiting dates for transition of our equipment and expect this to be in June.
- Natural Hazards Request For Assistance (RFA) process improvements to the DFES All Hazards Incident Management System (AHIMS) mean the Web-based Emergency Operations Centre (WebEOC), currently used to manage Level 2 & 3 incidents, will be extended to provide an end-to-end solution for managing Natural Hazard RFA's.
- Swan SES vehicles have been fitted with Automatic Vehicle Location (AVL) devices and members received training into the operation and maintenance.
- Community engagement events are being planned in line with the 2017 WinterSAFE campaign which runs until 30 Sept.
