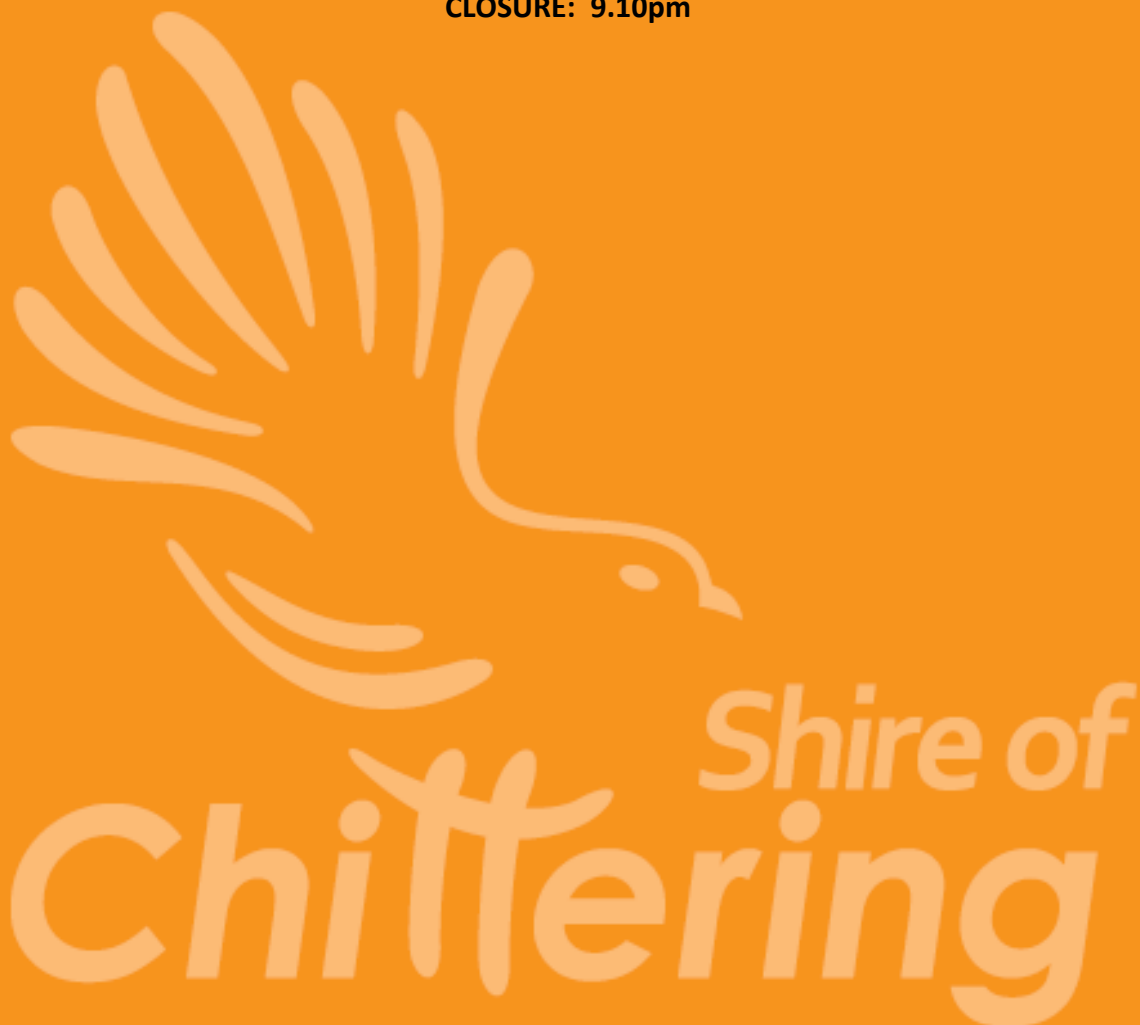

**7 ANNOUNCEMENTS BY THE DFES DISTRICT MANAGER NORTH EAST WITHOUT DISCUSSION**

Craig Garrett, DFES District Manager North East spoke on the following:

- The State Bush Fire exercise will be conducted on 15 October in various locations around the state, including Swan and Mundaring.
- An exercise is planned to test Rural Urban Interface firefighting in Chittering in early November.
- The public comment period for the Emergency Legislation review has closed, with feedback being collated.
- DFES had a display at the Perth Royal Show last week which was well received.
- The WA Fire and Emergency Services Conference was held last weekend with a number of awards presented to volunteers.
- The DFES North Region pre-fire season volunteer forum will be held at Joondalup on 25 October. Invites have been sent to BFB's.
- Bush Fire Action Week will be held 18-25 October to raise bush fire awareness with the public.
- Bush Fire information fact sheets and information booklets have been revised and will be available for community engagement.
- The Zone 2A response zone will be extended into the Shires of Chittering and Gingin to enhance response to fires, including automatic dispatch of fire bombers.
- A review of the Shires turn-out protocols will be undertaken pending BFAC and Shire agreement.
- Inspections of UCL/UMR land in the Shire to determine work required including fire breaks.
- The new Chittering Incident Control Vehicle (ICV) will be delivered to the Shire on Wednesday this week.

### 13.2 Additional Support for Permits

Jamie O'Neill said that, as some people had difficulty in obtaining permits to burn last year the Rangers will be available during business hours to issue permits if required:

- Residents should contact their local FCO/s if they are not available then contact the Shire;
- Rangers will inspect the property if not known to them;
- Rangers will advise the local FCO/s when they issue a permit. Members said that communication is important so that everyone knows what is happening;
- Rangers will not be available on weekends;
- Any concerns regarding the process contact Jamie O'Neill;
- Road verge burns need Shire authorisation. FCOs cannot issue a permit to burn a road verge;
- Communicate with each other.

### 13.3 Development of Response Plans for the Shire of Chittering

Members were referred to the map provided by Jamie O'Neill:

Ian Hollick said that he had visited ComCentre with Jamie O'Neill to discuss the current 000 agreement and procedure. Currently for a 000 call ComCentre have to contact the CBFCO and if not available the deputies who advise what Brigade/s to activate. This is a very different procedure to what is used by ComCentre for the metro area, which Chittering forms a part of. Ian said he was very impressed with the system used by ComCentre and cannot understand why the Shire had not changed to utilizing it sooner.

- Polygon System discussed;
- System may require some fine tuning, Brigades need to ensure they provide prompt SITREP's to ComCentre ;
- Chittering only Shire not using the system;
- Does not change the 000 Agreement;
- Each brigade has a different number and the brigade number in the Polygon is turned out. Can also elect to have two brigades turned out, this is a BFAC decision;
- Zone 2A currently stops at Chittering southern border. Proposal to extend it North of Bindoon, boundary Dewars Pool Road to Gingin townsite. Will receive auto air and DPAW response. This will commence 1 December.
- Will enhance mobilizing;
- High season and off season responses. When turning out need to remember that air and other support from 1 December 2014 will automatically be deployed and Brigades need to remember to turn them down if support is not required;
- Simple procedures will need to be introduced;
- Issue of emergency calls made from mobile telephone discussed. Often by the time the caller gets to the next cross road quite some distance away from the fire and ComCentre cannot control this;
- System offers improved response which benefits the community
- Need to decide whether to go 'direct turn out' or remain as is.



**COMMITTEE MOTION**

**Moved Steve Browne / Seconded Fred Hoogland**

**That the Chittering Bush Fire Services utilise the direct turn out option for 000 callouts effective immediately with the Community Emergency Services Officer informing the Department Fire and Emergency Services of the change, Enhanced mobilization through fire season only.**

**THE MOTION WAS PUT AND DECLARED CARRIED 9/0**

- Members requested that Rosa Park, Polinelli Road and Morley Road be included in the yellow sections on the map;
- Nothing changes for the Brigades turnout process, but members need to know that there is a possibility if a second Brigade turned out they may need to be stood down for dual turn out.

**13.4 Inaugural Fireman's Ball**

- Doreen Mackie advised that the ball was very successful and organisers should be congratulated.

**13.5 Formal Acknowledgement of the former Chief Bushfire Control Officer**

The CEO advised that during the handover meeting with Dennis Badcock, Dennis advised that he was not able to attend the Fireman's Ball to accept a gift from Council and suggested that he would prefer to be formally recognised at a Council Meeting. The Committee discussed the matter:

- CEO to discuss with Council re function.

Phil Humphrey raised the issue of acknowledging Dennis Harvey's contribution to Chittering Fire Services.

The CEO advised that it was his understanding that Dennis Harvey has not left the service, rather has restricted his involvement in the Muchea Brigade.

- CEO to contact Dennis Harvey to confirm whether he is remaining a member of the Chittering Fire Services.

**ACTION**

**The CEO to discuss with Council and organise the formal acknowledgement of Dennis Badcock, former CBFCO.**





### 13.6 Brigade Turnout to Motor Vehicle Accidents

Fred Hoogland said that there was confusion regarding turning out of Bush Fire Brigades following a motor vehicle accident near Hart Drive:

- Fire Services are not the HMA for motor vehicle accidents and therefore cannot stand anyone down.
- Important if Brigades are requested to assist they radio in when leaving the station, arriving at the accident and return to the station.
- Issue discussed with local branch: if ambulance officers need assistance from the local brigade they should go through their COMCENTRE who then contacts DFES COMCENTRE.
- Remember Brigade Members do not sign up to attend accidents and some may not be comfortable attending.
- Brigades need to discuss exposure of members to dangerous situation/s.
- Cr Norton, who was an attending officer at the accident, said that Ambulance Officers would not expect VBF members to help get someone out of a car and that it is handy to have a vehicle with flashing lights ahead of the accident to alert oncoming vehicles. She also suggested that members did not need to look in the vehicle when attending an accident to assist with fire etc.
- FRS are the main respondents for road accidents the VBFB back them up if needed.
- **Main point, make sure Members are comfortable attending an accident before leaving station and ensure COMCENTRE is advised when turning out, arriving at accident and when vehicles return to the station.**

### 13.7 Templates for Agenda Reports

As discussed at the August 2014 meeting, all Members will need to submit their reports prior to the distribution of the Agenda. Karen Parker is happy to assist those who are unable to use the template if Members provide her with a handwritten report or details via an email.

CESM will distribute the template to all Members.

### 13.8 Fire Services Vehicle Concession Conditions

Concerns were raised by Kim Haeusler re the licensing conditions placed on some of the Fire Services Vehicles. Some of the conditions appear to be indicate that if the vehicle is not being used for firefighting purposes it is deemed unlicensed.

The CESM is to follow up and provide Members with clarification.

**The CESM to contact the Department of Transport to seek clarification on conditions placed on some of the Fire Services vehicles.**
