4. CONFIRMATION OF PREVIOUS MINUTES

4.1 Local Emergency Management Committee meeting – Thursday, 26 May 2016

4.1 OFFICER RECOMMENDATION/ COMMITTEE DECISION

5. REPORTS

5.1 WA Police

Sergeant John Warburton introduced himself to the meeting and advised that he was the current Acting Senior Sergeant at Gingin Police. Sergeant Warburton briefed the meeting on the incident that occurred on Saturday 20 August 2016. Sergeant Warburton expressed that the emergency crews that were involved worked really well together. Due to the nature of the incident a section of Great Northern Highway had to be closed to traffic to allow St John Ambulance to attend the scene. Sergeant Warburton acknowledged how quickly the fire brigades were able to attend the scene, due to the annual Huw Davies Training Day being undertaken on the 20th August.

5.2 Department of Fire and Emergency Services

In the absence of Craig Garrett, Jamie O'Neill was to ask for his report to be sent through to be included with the minutes.

5.3 Department of Child Protection and Family Support

Lian Webb addressed the meeting and advised that Ryan Hamblion was undertaking a training session on Wednesday, 31 August. This training will be run every three or four months. Any members wishing to contact Ryan can do so via email ryan.hamblion@cpfs.wa.gov.au.

5.4 Australian Defence Force

Richard Symons informed the meeting that the Australian Defence Force recently had the Department of Fire and Emergency Services undertake some AIMMS training, and that they plan to undertake another one working in with others. The Force will be undertaking some planning exercises in October which will involve WA Police.

5.5 St John Ambulance

Rick Choules spoke to the meeting about the recent death near the Brockman Centre. The fire brigade volunteers who attended the scene before St John Ambulance arrived undertook CPR. Upon the arrival of St John Ambulance they asked the fire brigade volunteers to continue doing the CPR as they were

impressed with how they were performing it. This allowed the St John Ambulance officers to ready the vehicle ready for transporting the victim.

Mr Choules also spoke on the current recruitment drive as currently there are not many volunteer members in the branch. Due to the length of time it takes to process any volunteer applications it takes some time to process them all. The branch is always looking for volunteers, especially during working hours as most residents do not work in the townsites. Mr Choules informed the meeting that if a call comes through to Bindoon and there is nobody available the next point of call is through to Gingin. If there is nobody available in Gingin, then a call is put through to Bullsbrook. If Bullsbrook is also unavailable then a call is placed at Swan. The branch really needs to encourage more membership.

Mr Choules then informed the meeting about the new sub-centre being planned for Bindoon. The new building will include a training room and a wing for accommodation. Having accommodation will help to cater for volunteers who may come from, for example Wannamal (or further afield) and they are able to stay for a couple of nights. The new sub-centre will be located near the Chittering Health Centre (Great Northern Highway, Bindoon).

Cr Gordon Houston arrived at 10.40am, thanked Mr Sheridan for starting the meeting and then took the chair.

5.6 Shire of Chittering

5.7 Chief Bushfire Control Officer (Shire of Chittering)

Jamie O'Neill addressed the meeting and spoke with regard to the incident over the weekend.

Mr O'Neill also spoke on Swan joint training, training that was undertaken during June, ISB training, ICV training, SES quad-bikes (another one is being scheduled for November).

Mr O'Neill informed the meeting that there was site meeting with the Australian Defence Force at their reserve (located north Bindoon). The meeting was to raise the ongoing issue of communication at this reserve.

Mr O'Neill finished by saying that the Shire has sent out Firebreak Variations to residents, response has been overwhelmingly positive. The Shire's Rangers visit every property to assess the request before making a decision.

5.8 State Emergency Management Committee Secretariat

6. GENERAL BUSINESS

6.1 Contact details

Mr O'Neill informed the meeting that an attendee list was being sent around the table for attendees to complete. Mr O'Neill further advised that the Shire's Administration Support Officer will review/update LEMA contacts.

Sergeant John Warburton informed the meeting that when the initial call was logged with them there was a delay with the communication received. Sergeant Warburton advised that the Officer in Charge at Gingin should be contacted. With regard to Saturday's incident it took them about 50minutes to attend the site, so if there had of been an 'emergency' road traffic management would have been a major issue.

6.2 Post-incident reports

This had been dealt with under items 5.1, 5.5 and 5.7.

6.3 Treatment strategies progress

Mr O'Neill informed the meeting of the Risk Planning Process. Dave was currently in Lancelin and that this item will be actioned for discussion at the next committee meeting.

6.4 LEMC Exercise

6.5 Other Business

ADF Bindoon Training Area

Mr Badcock addressed the meeting; stating that it was more a comment for the Chief Bushfire Control Officer (Mr O'Neill) and Mr Hollick – communications [or lack off] at the Bindoon Training Area north of Bindoon. With the recent fire up in the reserve the lack of communication is putting fire control officer's lives at risk. This has always been an issue and with the change of officers at Defence the matter doesn't appear to be getting resolved/actioned.

Mr O'Neill informed the meeting that he met with representatives from Defence on Tuesday, 23 August at the location. Options suggested were to install an aerial and cable for portable repeater (plug & play) or install a permanent repeater the plug & play option is not ideal as it can take between 4/5 hours for a repeater to arrive. Mr O'Neill informed the Defence representatives of the last fire that was in this area volunteers were involved in a burnover. A repeater would cost something in the vicinity of \$18,000. The Shire's volunteer fire control officers who enter Defence land to fight a fire at the request of the department. Mr O'Neill advised that he would keep LEMC up to date with regard to a repeater.

Mr O'Neill advised that Defence have relied on the local repeater instead of their own repeater. There was also talk about having CCTV to monitor after lighting strikes. It is definitely a safety issue to send in volunteers where their communication is compromised and they are unable to communicate with other volunteers. Mr O'Neill advised that the minutes from Tuesday's meeting will be distribute to members once he receives them.

Traffic Management

Mr Badcock addressed the meeting with regard to BFB involvement at Saturday's incident as a representative of St John Ambulance, and the matter of traffic management. Mr Badcock was advised that if there is a crash on Great Northern Highway that it is out of their jurisdiction to manage traffic.

Sergeant Warburton addressed the meeting and spoke on a traffic accident which occurred on the Bindoon/Moora Road (in a 60km zone), he was attending the accident and coming up the hill a member of the general public was trying to manage traffic. The patient had already been removed from the accident site. This member of the general public believed that they were doing the right thing but they were putting themselves at risk as they did not have the appropriate training or PPE to manage traffic. Main Roads WA assist on their roads; and Shire officers assist where required. Members of the general public put themselves at risk as they do not have the awareness required.

Mr O'Neill informed the meeting that any incident is best to be called through the Comms Centre. Any calls called in are covered; i.e. volunteers who are asked to attend are covered as everything is logged.

Mr Hollick advised that the volunteer bushfire brigades core business was not traffic management. When they are called to an incident it is more a response to the call. Some members were forgetting to put is as a log, as they may be used as an emergency service; especially if there is the risk of fire or the jaws of life are required.

Sergeant Warburton advised that if the incident was not classified as a "MAJOR INCIDENT" they would not seek the services of the volunteer bushfire brigades. Their first point of contact is Main Roads WA.

Mr O'Neill advised that when the call is received through "000" it all depends on what information the responder is given, to what services are sent to the incident. It is therefore crucial for the information provided in the "000" is conveyed.

Binda Place Upgrade

Mr Sheridan informed the members of the upgrades currently being undertaken with Binda Place, Bindoon. The new road layout will only have one entrance into Binda Place, with the southern section becoming an 'exit only'. This will be a significant improvement to road safety, with the project's expected completion date January 2017.

7. NEXT MEETING

The next scheduled meeting of the Chittering Local Emergency Management Committee is scheduled for 10.30am on Thursday, 24 November 2016.
